

A Laboratory Experiment with a Single-Person Cobweb

Abstract: Among economists, one of the least fashionable theories of price adjustment is the "cobweb theorem" that static expectations will produce a counterclockwise pattern of prices and quantities around the intersection of market supply and demand functions. This note reports data from a laboratory experiment in which a fairly regular cobweb pattern was temporarily induced by the decisions of a single individual.
